

Detailed FY2010 Budget Released

On May 7, President Obama released the FY2010 Budget Appendix, which contains agency-specific requests for FY2010. The appendix followed the release of his budget overview on February 26 (see [The Source](#), 2/27/09). Congress approved the FY2010 budget resolution on April 29 (see [The Source](#), 5/1/09).

The following charts summarize President Obama's budget proposal for a number of programs important to women and their families. Comparisons to last year's funding levels reflect allocations provided by Congress in the FY2009 appropriations bills (for Defense; Homeland Security; and Military Construction, Veterans' Affairs, and Related Agencies, see [The Source](#), 9/28/09; for funding levels of agencies and programs in the remaining nine appropriations measures, see [The Source](#), 2/27/09).

The budget "proposes \$8.6 billion over ten years for a new mandatory program that provides funds to states for evidence-based home visitation programs for low-income families. When

implemented properly, such programs have sizeable effects on child outcomes. The policy is estimated to save Medicaid \$664 million over 10 years, including \$189 million in 2019.”

*President Obama’s budget replaces mandatory and discretionary abstinence-only education with “Teen Pregnancy Prevention Discretionary Grants.” The prevention grants would be funded at \$110 million in FY2010, of which \$75 million would be directed to programs “that have been proven through rigorous evaluation to delay sexual activity, increase contraceptive use (without increasing sexual activity), or reduce teenage pregnancy”; \$25 million would be directed to fund research and demonstration projects; and \$4.45 million would be used to fund longitudinal evaluations of prevention programs. (p. 38) The budget also includes \$50 million for a Teen Pregnancy Prevention Initiative “to support community-based and faith-based efforts to reduce teen pregnancy using evidence-based and promising models.” (p. 39)

*The budget states, “[T]he Committees on Appropriations should be notified that the United Nations has taken appropriate measures to prevent United Nations employees, contractor personnel, and peacekeeping forces serving in any United Nations peacekeeping mission from trafficking in persons, exploiting victims of trafficking, or committing acts of illegal sexual exploitation, and to hold accountable individuals who engage in such acts while participating in the peacekeeping mission, including the prosecution in their home countries of such individuals in connection with such act.”

**According to the budget, “The Global Health and Child Survival account is requested for the first time in FY2010 to provide a more comprehensive approach to global health programming. This account combines the Child Survival and Health, and Global HIV/AIDS Initiative accounts. The Global Health and Child Survival account funds health-related foreign assistance for the Department of State and the U.S. Agency for International Development (USAID).”
